Historical Note

The Seattle-King County Planning Council on Aging was established in 1973 in cooperation with King County and the United Way, evolving from a United Way Council on Aging created in 1956. The name was changed in 1984 to the Seattle-King County Advisory Council on Aging, and again in 1998 to the Seattle-King County Advisory Council on Disability and Aging Services. The Aging and Disability Services unit of Seattle's Human Services Department serves as the City's sponsor and liaison for the council.

Content Description

Records for the Seattle-King County Advisory Council on Aging include meeting agendas and minutes, along with background materials for meeting preparation and discussion. These materials include bylaws, membership lists, committee reports and other supporting materials. Topics addressed include transportation (including taxi and bus fares), housing, health, outreach, advocacy, planning and related

legislative issues. Calendars for each month include committee meetings, other forums and events, and Advisory Council meetings. Background material includes minutes for Washington State Council on Aging Meetings.
