## Historical Note

The Big Cottonwood Association (1979-1989) was organized to serve as a liaison for property owners, government agencies, commercial interests, and users of public lands within the canyon. Goals of the association include improving public services within the canyon, input into zoning and long-range development plans, and the preservation of the environmental features and wildlife of the area. Membership in the organization was limited to those who have property interest in the Canyon.

Big Cottonwood Canyon is a great source of tourism and economic flow for Utah and the Big Cottonwood Canyon Association is a form of representation for the inhabitants of the canyon. The Association concerned itself with policies that would affect the canyon and documents included were collected by Jean Taylor, President of the Association from 1979-1989 (non-inclusive).

## Content Description

The Big Cottonwood Canyon Association records consist of correspondence, meeting, and research documents. The records also contain collected periodicals and reports as they relate to the Association.
